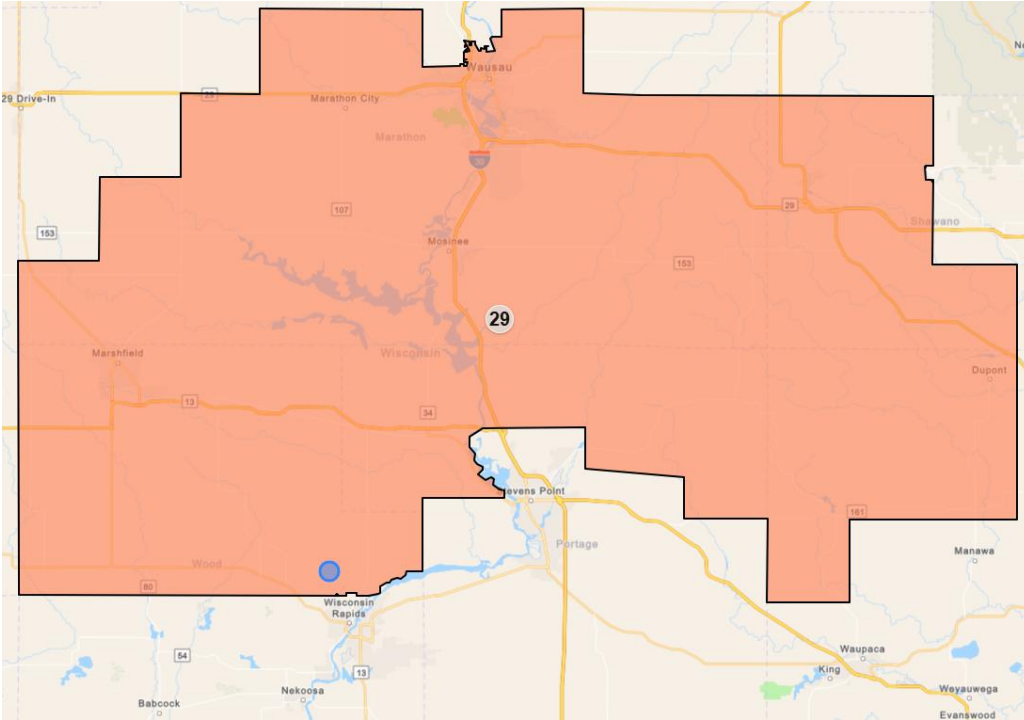

For church members who live in a ~40-mile radius of Port Edwards

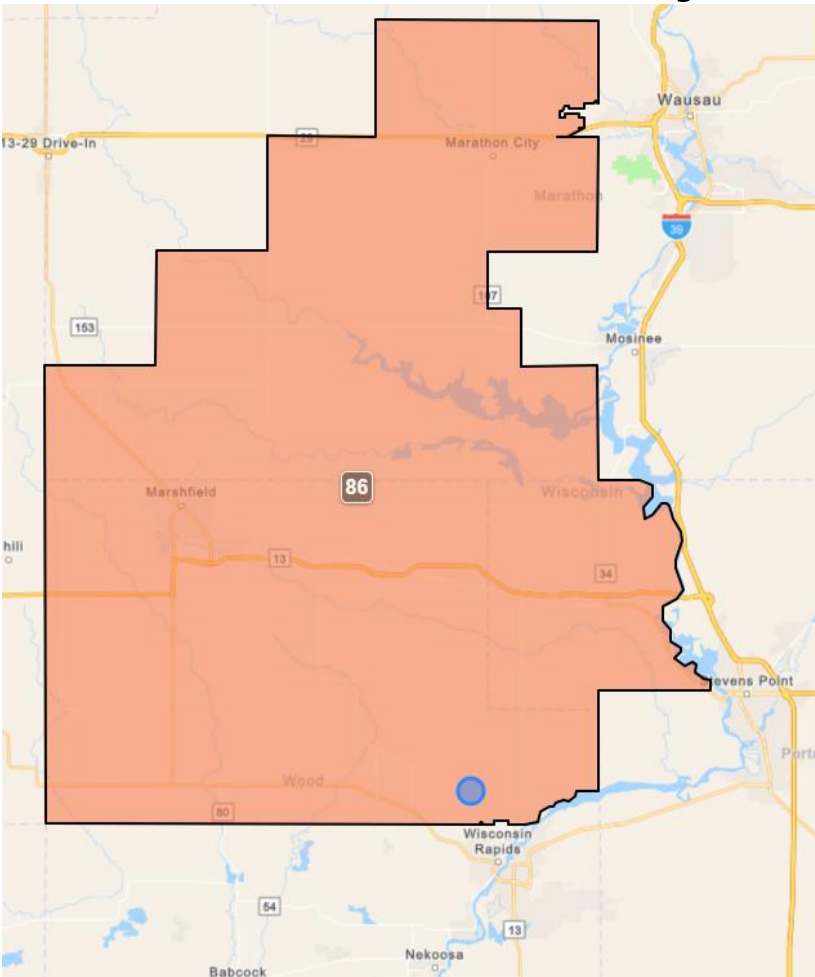
